Neil Wilkinson and Katie Heggemeier participated in the Florida Mosquito Control Association's legislative meeting in Tallahassee to educate State regulators and legislators on issues affecting mosquito control in Florida. The group met with Lee County delegates including Senator Benacquisto, Representative Caldwell, Representative Fitzenhagen, Representative Eagle, and Representative Rodriguez. Another group from Collier Mosquito Control District was able to meet with Senator Richter. Additionally, the Director and a few others from the association met with Deputy Commissioner of Agriculture, Lisa Conti and Director of the Division of Agricultural Environmental Services, Andy Rackley regarding the Department's proposed changes to Chapter 388, the mosquito control law for the distribution of State aid to mosquito control districts. Key issues included continuation of funding levels for local aid to mosquito control districts from the waste tire trust fund, funding for operational mosquito control research, and concerns over proposed legislation to roll certain special taxing districts into county government.

Dr. Kaufman of the University of Florida released information to the public about the "Shaggy-haired gallinippers (Psorophora ciliatia) infesting the Sunshine State." He also stated "that this year's rains could produce a bumper crop of these mosquitoes." This mosquito is very large and it was rumored that when it bit you, it may feel like you have been stabbed. Shelly appeared on all networks and explained that we are aware of the Phorophora ciliata and that we are very experienced to take care of a bumper crop.
