In an effort to improve mosquito control in Lee County through cooperation and research, a meeting was held at the District on November 7 and 8 with representatives from Florida Department of Environmental Protection, Florida Department of Agriculture and Consumer Services, Florida Fish and Wild life Conservation Commission, Florida Gulf Coast University and District personnel. The meeting was held to discuss coordinated burning of salt marsh habitats between managing agencies and a funded research project to determine nontarget effects of aerial adulticiding over State managed lands. FGCU has partnered with the District to do the non-target adulticiding study and was successfully awarded a \$100K grant from DOACS. The study will be completed next season. The agencies will continue to meet with the District in the future to coordinate mutually beneficial marsh burns.

Shelly Redovan gave her presentation to the Sanibel Community House November 15th. Shelly spoke of the procedures and challenges that Lee County Mosquito Control District faces when treating Sanibel Island. Several of her group were from the Sanibel Conservancy and the City of Sanibel.
