Spring is the start of higher than normal tides and summer rains bring larvae. May is the start of truck traps to our District and this year you will see a major change to the truck-trap program. May 1st, we added one more truck trap and six (6) new runs. We have needed this change for some time and with this added truck; we will add more efficiency to our program by getting all the surveillance done by midnight. With the addition of the six runs, each truck, now has 13 runs. With 52 runs on the mainland and two (2) runs on Boca Grande, Lee County is now covered with a total of 52 runs. LCMCD has a south run for Sanibel, Iona, Ft. Myers Beach and Bonita with their connecting beaches. The west truck trap will cover runs on Pine Island, Cape Coral and parts of No. Ft. Myers. The north trap truck will have the remainder runs of No. Ft. Myers, East Ft. Myers and Ft. Myers. The newest trap truck has an east run covering San Carlos Park, Corkscrew Rd., Lehigh Acres, Alva and Buckingham. The new runs were added in Bonita Springs, Cape Coral and LeHigh Acres. NONE of the original runs were changed or dropped; we just have new run numbers and new drivers. The above information and map provided by Jim Burgess.
