Major improvement in flight safety

Pond Watch, the citizen volunteer monitoring program, accepts samples from storm-water ponds the 2nd Monday of every month. The results help inform residents about the conditions of their ponds and guide them on best manage-

ment practices that can alleviate the problems with aquatic weeds. Biologist, Ernesto Lasso de la Vega, is the coordinator of the program.



Airplanes and helicopters have been around a long time, if fact it has been said that there are no new types of accidents just new people making the same mistakes. With all the improvements and enhancements to obstruction avoidance during night missions (NVG's, Reflective Tower Tape, GPS) it is rare that someone invests the time it takes to even make it safer. You would think that seeing a tower while flying at low altitude is easy, but the fact is that when you are as low as we fly, even if the towers that have lights tend to blend in with the sea of lights all around the county.

Jim McKeever, working closely with Gene Sutton and the folks at AgNav, has devised a way to warn the pilots of a potential collision with an obstacle. With this new program, the Guia looks forward, in the direction of flight and warns the crew 45 seconds in advance of a possible obstruction in the way. The first warning is a red circle that draws attention to the conflict. The circle varies in size depending on the speed of the aircraft. If an evasive maneuver is not initiated, the entire heads up display begins to flash until the pilot alters the course sufficient to avoid the possible collision. This new program, written in part by Jim, has now been flight tested and is ready to go to work, adding yet another safety feature. This is a clear example of an employee having a vision for increasing safety and doing something about it. We are truly blessed with outstanding employees at the District!
