Some of the areas for concern and addressed to date are: Leitner Creek, Rosemary Creek and Oak Creek all of which flow directly into the Imperial River. A continuous work project between our District, City of Bonita Springs and Shangri-La Springs' staff to help eliminate water lettuce from Oak Creek has yielded optimum results. Thanks largely to the cooperation and with the excellent work efforts performed by the folks from Shangri-La Springs, continuous site monitoring and timely action plans have directly benefited LCHCD's long-term plant management strategies for our local waterways.

Dangerous Goods Seminar—October 13th, Angel Monges, Supply Coordinator, and Brian Cotterill, Safety & Compliance Officer, attended a *FedEX Shipping Dangerous Goods* seminar in Orlando. This class trains shippers the necessary procedures to identify, pack, and label the document for shipping that may pose a risk to health, safety, property or environment. We all were reminded of the crash of ValuJet in 1996 where improperly packaged oxygen generators caused a crash and the death of 110 people.



After three days, this class ended with a proctored exam leading to a goal of a FedEx Certificate of Completion. One of the text books was over 900 pages deep.



"Our Mosquito Education Outreach Program participated in the annual J.N. Ding Darling National Wildlife Refuge *Family Fun Day*, Sunday, Oct. 19th. Eric Jackson, Education Resource Specialist and students from FGCU shared living aquatic macro-invertebrates; cased native and exotic insects and information on how to reduce the amount of mosquitoes from yards with the refuge visitors. Younger participants made models of mosquitoes and learned how mosquitoes undergo metamorphosis."
