Commissioner Brantley announced that this is the Public Hearing to Adopt the Tentative Millage rate and a Tentative Budget for the fiscal year 2024-2025.

NEW BUSINESS:

10320_Auditor selection– Request the Board approve a new contract for the Districts' annual audits with Carr, Riggs, and Ingram, LLC (CRI). The Board's Auditor Selection Committee ranked CRI, LLC as the 1st choice. The contract will be for three years with two optional one-year renewals.

Commissioner Brantley requested Board approval for the 10320_Auditor selection. Commissioner Bowen moved to approve 10320. Commissioner Farrar seconded the motion. The Board approved unanimously; motion passed.

EXECUTIVE DIRECTOR DISCUSSION: Executive Director Dr. Hoel discussed the tentative millage rate to be levied at 0.2200 mills (\$0.2200 per \$1,000.00) for fiscal year 2024-2025. The tentative millage rate of 0.2200 mills is more than the rolled back rate of .2134 by 3.09%. The Tentative Budget for Lee County Mosquito Control District for fiscal year 2024-2025 is \$46,717,412.

RESOLUTION TO ADOPT THE TENTATIVE MILLAGE RATE:

Vice Chairman Brantley read Resolution 24-01 to adopt the tentative millage rate for fiscal year 2024-2025.

Vice Chairman Brantley requested a motion to adopt the tentative millage rate of 0.2200 mills for the fiscal year 2024-2025. Commissioner Scott moved the motion including a 3.5% COLA, Commissioner Bowen seconded the motion. The Board unanimously approved, motion passed.

Duly adopted at a public Hearing this 4th day of September 2024 at 5:35 p.m.


RESOLUTION TO ADOPT THE BUDGET:
